**Amendment to NHAI/Policy Guidelines/External Professionals & Young Professionals  
(No.1.3.1.15/2017 dated 04<sup>th</sup> Oct. 2017)**

**Sub: Guidelines and procedures for engaging External Professionals and Young Professionals in NHAI.**

Policy guidelines were issued vide circular No.1.3.1.12/2017 dated 21.06.2017 on the above mentioned subject.

2. As a one-time measure, recruitment procedure for 2017 for engagement of YPs (Technical) may be decentralized at PIU level as per the following composition of Screening-cum-Selection Committee comprising following three officers:

Screening-cum- Selection Committee
<ul style="list-style-type: none"><li>• Respective PIU officer (Preferably PD)</li><li>• Two officers to be nominated by RO.</li></ul>

3. The vacancies @ one YP (Technical) for each PIU would be advertised by the NHAI HQs as per the guidelines dated 21.06.2017. The advertisement shall contain following details:

- List of PIUs.
- The date & venue of walk-in-interview. The candidates would be called for a Walk-in-Interview on one common date at respective PIUs to avoid multiple candidature for engagement as YP for different PIUs.

4. Additional members for Screening-cum-Selection Committee required PIU wise be forwarded by RO to HQ NHAI by 10 Oct. 2017. These additional manpower will be provided by HQ NHAI. After finalization of the above process on the basis of valid GATE score merit, the respective RO shall approve the recommendations of the Screening-cum-Selection Committee of respective PIUs and display the result same day or next day.

5. The other provisions of the guidelines and procedure for engaging External and Young Professionals in NHAI circulated vide Policy Guidelines No.1.3.1.12/2017 dated 21.06.2017 shall remain unchanged. The selected candidates will join by 01 November 2017.

6. The above amendment would lapse after finalization of recruitment of YPs (Technical) as per above procedure and thereafter the provisions contained in Policy Guidelines No.1.3.1.12/2017 dated 21.06.2017 would prevail with respect to screening and selection of the candidates for YPs.
