### NHAI/Policy Guidelines/Annual Property Returns/2018

No. 1.3.2.24/2018, Dated the 15<sup>th</sup> March, 2018

(Decision taken on File No. NHAI/11041/96/2014/HR-IV)

**Subject:- Policy regarding Annual Property Returns and Financial transactions in respect of the officers working on deputation in NHAI.**

Every Government servant, under Rule 18(1) of Central Civil Services Conduct Rules, 1964, is required to submit a return of his assets and liabilities on his first appointment to any service or post, giving the full particulars regarding:-


- (a) The immovable property inherited by him, or owned or acquired by him or held by him on lease or mortgage, either in his own name or in the name of any member of his family or in the name of any other person;
- (b) Shares, debentures and cash including bank deposits inherited by him or similarly owned, acquired, or held by him;
- (c) Other movable property inherited by him or similarly owned, acquired or held by him
- (d) Debts and other liabilities incurred by him directly or indirectly.

2. The above guidelines are mutatis mutandis applicable for NHAI as per policy.

3. Further, CVC, vide its office memorandum no. 003/SHT/031-362386 dated 10.11.2017 has advised NHAI that the details of Annual Property Returns and financial transactions may be obtained in respect of all officers working on deputation in NHAI at the time of joining NHAI from their respective cadre controlling authorities and also to digitalize the data including any additions/deletion as per respective Annual Property Returns.

4. In view of the above, all cadre controlling authorities in Administration, NHAI are requested that the requisite details in respect of all officers joining on deputation in NHAI henceforth, may be obtained from their respective Cadre Controlling Authorities in pursuance of the ibid CVC's advice and Conduct Rule.

National Highways Authority of India (NHAI) may please refer to their letter No. 13030/14/2003-Vig/661 dated 06.10.2017 on the subject cited above.


2. The Commission has perused the report submitted by CVO, NHAI and advises CVO, NHAI as under:-

(a) Closure of the complaint against Dr. GVS Raju, then PD, NHAI as he has retired voluntarily on 15.09.2015 and case being quite old, it is fait accompli now.


(b) The matter of hiring of fake vehicles is a serious matter. The commission advises to undertake verification of hired vehicles of all PIUs, and expenditure incurred on them.

(c) CVO, NHAI is advised to ascertain the total expenditure incurred on Vehicle No. AP 5 AC 1177 used by Dr. Raju as PD.


