

I am directed to refer to this Ministry's letter No. A-12025/2/2013-E-II (B) dated 13.01.2013 and subsequent reminders on the subject cited above requesting for amending the Regulations for the post of Chief General Manager (Tech) as per DoPT instructions issued vide O.M.No.AB-14017/61/2008-Estt.(RR)/Pt. dated 18.01.2011. Copy of the letter dated 13.01.2013 is enclosed for reference.

2. It is requested that a copy of the amended Regulations in terms of DoPT's instructions as above may be forwarded to this Ministry for record. In case no amendment has been issued it is once again reiterated that necessary action may be initiated immediately to amend the Regulations as per DoPT guidelines under intimation to this Ministry.

3. The competent authority in the Ministry have also desired that after amendment of the said Regulations NHAI may issue open advertisement calling for application from internal candidates of NHAI as well others eligible candidates for filling up the vacant posts of Chief General Manager (Technical) in NHAI.
