POLICY MATTERS: ADMINISRTRATION/FINANCE No.1/2007 (Decision Taken on File No. 11041/217/2007-Admn)

Sub: Work Allocation to Chief General Managers

- 1. Vide Policy Circular No. 11041/21/2005-Admn dated 4.12.2006, Chief General Managers were designated as State Nodal Officers of NHAI for individual States. The objective of appointing State Nodal Officers was to have all the information related to projects for each State and for having effective coordination with the State Governments for addressing the issues mainly related to pre-construction activities. This work was in addition to the assigned work of contract management of projects/sub projects handled by the CGMs of specific NHDP Phases. Under the existing system, CGMs were allocated work on the basis of Corridor wise concept keeping in view the NHDP Programme.
- 2. It has been felt that the objective of having effective management of projects/sub-projects in a State would not be fulfilled with this arrangement and the objective may be better achieved when senior officers of the level of the Chief General Managers are made directly responsible for implementing all projects/sub-projects in a State under all phases of NHDP. The handling of all NHDP projects/sub-projects in the State by designated Chief General Manager will enable him to have a first hand knowledge of all issues relating to contractual matters of projects/sub-projects and also of the problems/issues relating to the State Government. This will help in quick resolution of problems/issues arising during pre-construction/ construction periods, effective monitoring and ensuring timely completion of projects/sub-projects under NHDP.
- 3. In view of above, it has been decided to allocate each State to a Chief General Manager for managing and implementing all work relating to NHDP in that State. The Chief General Manager will, interalia, be responsible for the following for the group of States allocated to him:
- Implementation and contract management of all projects/sub-projects under all phases of NHDP.
- ii) Corridor Management

- iii) Commercial Operations and Tolling
- iv) All pre-construction activities including Land acquisition, DPRs/Feasibility Reports of all projects/sub-projects.
- v) Coordination with State Government and Central Government departments.
- vi) All Parliamentary related matter pertaining to the State.
- vii) All RTI related matter pertaining to the State
- viii) All other allied and related matters pertaining to the State.
- 4. The following Chief General Managers who were hitherto looking after various Technical Divisions will look after the work relating to the States allocated to them as under:

5. Delhi-Mumbai, Mumbai-Chennai, Chennai-Kolkata, and Delhi-Kolkata Divisions of Golden Quadrilateral; East-West | & II and North-South | & II Divisions of North-South, East-West Corridors; BOT | & II Divisions, Port Connectivity Division and Corridor Management Division will function directly under the respective Members. The Chief General Managers will be reporting to the respective Members in respect of projects/sub-projects concerning their group of States.

- 6. Those of the above nine Chief General Managers who were given charge of various Cells vide Office Order No. NHAI/11041/199/2006-Admn dated 11th September, 2006 will continue to look after the work relating to the Cell in addition to the above new work allocation.
- 7. For efficient discharge of their new duties all the Divisions at the Headquarter will assist all CGMs for the work relating to respective Divisions. The Divisions will report to Members through the concerned CGM in respect of matters relating to that particular State.
- 8. The Project Implementing Units and Corridor Management Units in the States will report to the Chief General Managers looking after the affairs of that State and also to the concerned Division of the Headquarter depending upon the nature of work.
- 9. The existing allocation of work of CGM (IS&P) and CGM (PQ) will remain unchanged. All previous orders regarding allocation/distribution of work to Chief General Managers stand superseded by this order.
- 10. The above new work allocation to Chief General Managers will come into effect immediately.
