NHAI/Policy Guidelines/Engagement of Technical Consultants/2020

Policy Circular No. 10.1.25 Dated 9th December 2020

[Decision Taken on File No. NHAI/11018/01/2008-PQ-Parrrt (3), E-File No.44497]

Sub: Addendum to Policy Guidelines issued vide No. 10.1.23/2020 dated 4th September, 2020.

Ministry of Road Transport and Highways vide O M No. F No.G-20016/01/ 2020-TF-II dated 17.11.2020 has conveyed the instructions issued by Department of Expenditure, Ministry of Finance regarding reduction of Performance Security for all existing contracts. The same has been implemented in NHAI vide NHAI/Policy Guidelines/Standard DCA Document HAM/2020 Policy Circular no. 3.1.27 dated 19.11.2020.


2. Accordingly, the table under Annexure-C of Policy Guidelines specifying Omnibus Bank Guarantee provisions issued vide no. 10.1.23/2020 dated 04.09.2020 as addendum to standard RFP documents for engagement of Technical Consultants is amended as below: -

3. The benefit of the above reduced Performance Security will not be given in the contracts under dispute wherein arbitration/ court proceedings have already been started or are contemplated.

4. This will be applicable for all the consultancy tenders/contracts issued/concluded till 31.12.2021 and provisions should be made in RFPs/Contracts accordingly.
