Sub: Movement of Over-Weight and Over-Dimensional Consignments (OWCs/ODCs)

On the representation of various Ministries, Departments, CPSUs and Stakeholders involved in movement of Over Weight and Over Dimensional Consignments (OWCs/ODCs) on the National Highways, a letter No.RT-11042/13/2008-MVL was issued on 16<sup>th</sup> September, 2013 by Ministry of Road Transport & Highways for further streamlining the process of grant of permission for movement of OWCs/ODCs. In pursuance thereof, this Ministry is in the process of getting such structures surveyed, so that a considered decision may be taken on the movement of OWCs/ODCs.

2. It has been brought to the notice of this Ministry that several consignments are withheld in want of survey report of critical structures like bridges, tunnels etc. on the National Highways. In order to prevent delay in grant of permission for movement of OWCs/ODCs on the National Highway, it has been decided that the implementation of Circular No. RT-11042/13/2008-MVL dated 16<sup>th</sup> September, 2013 be kept in abeyance until completion of survey and examination by this Ministry. In the interim, all requests for grant of permission will be processed as per Circular No. RT-11042/13/2008-MVL dated 22<sup>nd</sup> January, 2010 and Circular No. RT-11042/13/2008-MVL dated 3<sup>rd</sup> September, 2008. The Transport Commissioners are requested to process the grant of permission expeditiously.
