CIRCULAR NO: NHAI/COMMERCIAL OPERATIONS/106


This circular is issued in supercession of circular no/. 96 dated 23.5.2008 and in continuation to our circular no. 88 dated 15.6.2007. The only amendment made is at Sr. No. 4 & 5 of the evaluation criteria sheet where the 10 marks for local language has been bifurcated between knowledge of local language and bona-fide resident (based on domical certificate) of the concerned State.

A standardized assessment sheet to judge the suitability of the ex-servicemen during interview is enclosed. All PDs/PIUs are requested to strictly follow the criteria as per assessment sheet during the selection process, to ensure uniformity, transparency and recording of the assessment by the committee.

While issuing interview letters, sponsored ex-servicemen must be asked to bring the following documents in original and attested/notarised photocopy to verify and form the basis for marking along with financial bids:-

1. Retired Officer's Identity Card
2. Pension Pay order (PPO)
3. Retirement Medical Certificate
4. DGR Registration Certificate
5. University Degree
6. Certificate in support of computer knowledge
7. 10th class certificate of the Board in support of local language knowledge
8. Detail of Present establishment and proof of manpower (last audited balance sheet etc.)
9. Scroll of Gallantry/Presidential Award.

This issues with approval of Competent Authority and is to come into force with immediate effect.
