Subject: Constitution of Conciliation Committee of Independent Experts -3 (CCIE-3) - Reg.

NHAI vide Policy Circular no. 2.1.23/2017 dated 02.06.2017 established a Conciliation and Settlement Mechanism for contractual disputes under the contract agreements with the Contractors/ Concessionaires/Consultants of NHAI. An amendment to this Policy Circular alongwith Standard Operating Procedure (SOP)/ Methodology for Conciliation was also issued vide Policy Circular no. 2.1.23 (1)/2017 dated 19.06.2017. Modifications in the SOP for conciliation of disputes were further issued vide Policy no. 2.1.27/2018 dated 18.07.2018 and 2.1.28/2018 dated 03.08.2018.

2. In order to expedite the conciliations, NHAI Board in its meeting held on 25.04.2019 (Agenda item no 138.05) has decided to form another Conciliation Committee of Independent Experts (CCIE-3). Accordingly, the following Conciliation and Settlement Committee has been constituted for the purpose:-
