### NHAI/Policy Guidelines/Dispute Resolution /2021

Policy Circular No. 2.1.49, Dated 24<sup>th</sup> May, 2021

(Decision taken on e-office File No. E 5472 )

Sub : Establishment of a Conciliation & Settlement Mechanism for Contractual Disputes under the contract agreements with the Contractors/ Concessionaires/ Consultants in NHAI - Regarding Extension of time period of panel of Independent Experts of Conciliation Committees of Independent Experts (CCIEs 1 & 2).

NHAI vide Policy Circular No. 2.1.23/2017 dated 02.06.2017 established a conciliation and settlement mechanism for the early resolution and settlement of claims arising out of the contractual disputes under the contract agreements with the contractors/ concessionaires/ consultants in NHAI. The two Conciliation and Settlement Committees were constituted and published vide para 4.3 of Policy Circular 2.1.23/2017 dated 02.06.2017. As per Annexure-1 of the Policy Circular, the panel of Independent Experts approved under these guidelines was valid upto 01.06.2020.


2. At present, the composition of these two Committees is as under :
