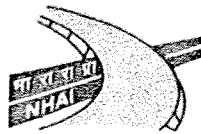

This is with reference to earlier circular dated 01-11-2012, it has been decided to amend para 3. The amendment is enclosed as Annexure – 1.

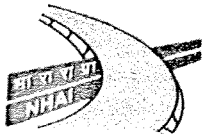

CIRCULAR

Sub.: Notification dated 23.07.2012 issued by Delhi Government notifying the "Court fees (Delhi Amendment) Act, 2012" – Introduction of court fees for setting aside the Arbitral Award or appeal under Arbitration & Conciliation Act 1996.

This is in continuation to circular dated 01.11.2012 on the subject matter, para 3 is amended as follows :

Existing para 3	Amended para 3
In view of the above, all ROs/PIUs are advised to comply with the Court Fee Act, 1870 and its amendment notified vide notification dated 23.07.2012. The payment of court fee being statutory in nature it needs to be paid with the approval of the Competent Authority, in respect of cases filed under Section 11, 27, 34, 36 & 37 of Arbitration and Conciliation Act, 1996 by the concerned RO/PIU. Hence, for filing of appeal and application for setting aside the Arbitral Award after 01.08.2012, the ad valorem court fee as mentioned in Clause 8 (a) of the said notice will also be required to be paid while moving the application under the Act.	In view of the above, all ROs/PIUs are advised to comply with the Court Fee Act, 1870 and its amendment notified vide notification dated 23.07.2012. The payment of Court fee being statutory in nature needs to be paid in respect of cases filed under Section 11, 27, 34, 36 & 37 of Arbitration and Conciliation Act, 1996 by the concerned RO/PIU. Hence, for filing of appeal and application for setting aside the Arbitral Award after 01.08.2012, the ad valorem court fee as mentioned in Clause 8 (a) of the said notice will also be required to be paid while moving the application under the Act.
