(Decision taken on DR & QA Cell's File No. NHA/DR & QA Cell/ARB/2005)

Sub.: Fee and other expenses payable to the Dispute Review Experts and Dispute Review Board Members.

It has been decided that the fee and other charges payable to the Dispute Review Experts and Dispute Review Board Members shall be as given in the schedule below :-

| SCHEDULE | | |

| Sr. No. | Particulars of fee and other charges | Amount payable |
| 1 | Retainer-ship fee, secretarial assistance and Incidental Charges (telephone, fax, postage etc.) | Rs.10,000/- per month for one package and maximum of Rs.20,000/-per month for 2 or more packages |
| 2 | Daily fee during site visit | Rs. 4,000/- |
| 3 | Traveling Expenses | Economic Class by Air, A C First Class by train and A.C Taxi by road, |
| 4 | Lodging | (i) Up to Rs. 10,000/- per day (metro cities) (ii) Up to Rs. 5000/- per day (other cities) (iii) Rs. 2000/- per day (own arrangement). |
| 5 | Extra charges for days other than hearing / meeting days (travel upto a maximum of 2 days on each occasion) | Rs. 2,000/- per day |

Note:-

- Lodging, boarding and traveling expenses shall be allowed only for those members who are residing 100 kms. away from place of meeting.
 - Delhi, Mumbai, Chennai, Kolkata, Bangalore and Hyderabad shall be considered as Metro Cities.
 - The fee indicated above shall be applicable w.e.f. 01.01.2008 to the already constituted DRE/DRBs and for future DRE/DRBs.
