POLICY MATTERS: TECHNICAL (69 /2006)

[Decision taken on DR&QA Cell's file No. NHAI/DR&QA Cell/ARB (Tech. Leg Exp.)/2005]

Sub.: Engagement of Techno Legal Experts to deal the Arbitration Cases on behalf of NHAI.

It has been decided that the Techno Legal Expert can also be engaged to defend arbitration cases on case to case basis.

2. Techno Legal Expert should be a retired Civil Engineer not below the rank of Superintending Engineer with atleast 8-10 years experience in conducting arbitration cases and preferably a law graduate.
3. The name of Techno Legal Expert would be proposed by PIU/CMU concerned or technical divisions/DR & QA Cell at Headquarter. The name will be approved by the Member concerned.
4. No regular advocate will be engaged where Techno Legal Expert is engaged. However, in exceptional circumstances where the case requires the assistance of legal expert along with Techno Legal Expert, specific approval of Member concerned shall have to be taken.
5. The fee structure for engagement of Techno Legal expert is enclosed as Annx. 'A'.
