**(Decision taken in File No.NHAI/DR&A Cell/Advocate/2012)**

**Subject: Schedule of fee for Legal Charges to Advocates/Techno Legal Expert/Law Firms – Amendment to Policy Circular Admn/Fin (140/2014) dated 04.06.2014**

In continuation to Policy circular Admn./Fin (140/2014) dated 04.06.2014 issued for Schedule of fee for Legal Charges to Advocates/Techno Legal Expert/ Law Firms, it has been decided to issue an amendment to Note (1) provided on page 3 as given below:

Description	Provision of Existing Policy Circular	Amendment to be made
Note (1)	If an Advocate is required to undertake an outstation journey in connection with any matter of NHAI, he shall be entitled to a sum of Rs. 10,000/- per day for Senior Advocate and Rs.5,000/- per day for Junior Advocate over and above the fee payable to him. Lodging, boarding, travelling and local travel expenses will be allowed only for those Counsels who are 100 kms away from their HQ to the place of meeting.	If an Advocate is required to undertake an outstation journey in connection with any matter of NHAI, he shall be entitled to a sum of Rs.10,000- per day for Senior Advocate <b>(designated by Hon'ble supreme Court &amp; High Courts only)</b> and Rs.5,000/- per day for Junior Advocate over and above the fee payable to him. <b>If a Techno Legal Expert is required to undertake an outstation journey in connection with any Arbitral matter of NHAI, he shall be entitled to a sum of Rs.5,000/- per day (as in case of Junior Advocate) over &amp; above the fee payable to him.</b> Lodging, boarding, travelling and local travel expenses will be allowed only for those Causels who are 100 kms away from their HQ to the place of meeting.

2. Other terms and conditions contained in said circular shall remain unaltered.
