POLICY MATTER – Technical (131/2013) **(Decision taken in the 93rd Meeting of the Authority held on 26.3.2013)**

Sub: Delegation of powers for approval of bids for award of works under EPC/Item rate mode, OMT projects and Collection of User fee.

Following procedure has been approved by the Authority in its 93rd Meeting held on 26.3.2013 for award of works under EPC/Item rate mode, OMT Projects and collection of user fee:

- i) EPC/Item Rate:
 - a) The bids for award purpose will be approved by Chairman, NHAI if the response to the bid is adequate (more than 2 valid bids) and the amount quoted by the preferred bidder is not more than 10% of the estimated civil cost approved by the Competent Authority.
- ii) OMT Projects:
 - a) The bids for award purpose will be approved by Chairman, NHAI, if the response to the bid is adequate (2 or more valid bids) and the quoted first year concession fee is upto 5% less than 'First Year concession Fee' as at the time of SFC approval.
 - b) In case single bid is received, the tender process may be cancelled and re-bidding done except in case where due to other reasons, like difficult conditions, law and order etc., the response is expected to be poor. In case re-bidding also results in receipt of single bid, the proposal may be put up to Board for consideration. Board may accept single bid after examining the reasonableness of the same.
- iii) Collection of User Fee:
 - a) The bids for award purpose will be approved by Chairman, NHAI, if the response to the bid is adequate (2 or more valid bids) and the quoted amount is upto 5% less than the 'Annual Potential Collection (APC)' of the project.

- b) In case single bid is received, the tender process may be cancelled and re-bidding done except in case where due to other reasons, like difficult conditions, law and order etc., the response is expected to be poor. In case re-bidding also results in receipt of single bid, the proposal may be put up to Board for consideration. Board may accept single bid after examining the reasonableness of the same.
