CIRCULAR

Sub: Consideration of RFAQ - 2013 results declared by MoRT&H in the RFQ of EPC projects of NHAI - Regarding.

Queries are being raised by various Technical Divisions whether the RFAQ - 2013 results declared by Ministry may be used for the project specific RFQ of NHAI being invited by NHAI on EPC mode.

In this regard, it is clarified that the invitation to qualification should be extended to those who have already pre-qualified in the annual pre-qualification of MoRT&H as well as others also who are interested to get qualified for project specific RFQs.

In this regard, Competent Authority in NHAI has approved following amendment to be incorporated for the project specific RFQs for projects to be invited in EPC mode for adoption by all Technical Divisions.

Sl. No.	Amendment to RFQ
1	Clause 1.1.6 as below inserted after Clause 1.1.5 This invitation to qualification is extended to those who have already prequalified in the annual prequalification of MoRT&H as well as others also who may now like to get qualified. Those prequalified by MoRT&H at RFAQ stage should enclose the letter of prequalification issued by MoRT&H and need not furnish the information sought in Clause 3.4.1, 3.4.2 and 3.4.3 of RFQ document.
2	Sub-clause (vii) inserted below Clause 2.13.2 (vi): “(vii) letter of Pre-qualification issued by the MORTH in respect of the Applicants who have been Pre-qualified by the MORTH at RFAQ Stage.”
3	Footnote to Clause 2.13.2 (vi) inserted: “The Applicants who have been pre-qualified by the MORTH at RFAQ stage need not submit these details.
4	Add sub-clause (l) to Clause 2.19.1 as below: “(l) it contains letter of pre-qualification issued by the MORTH for Applicant in respect of Applicant pre-qualified by the MORTH at RFAQ stage.
5	Add Clause 3.3.4 as below after Clause 3.3.3: The Applicants who have been Pre-qualified at RFAQ Stage should enclose the letter of Pre-qualification issued by the MORTH and need not furnish the information sought in Clause 3.3.1, 3.3.2 and 3.3.3 above.
6	Add Clause 3.4.4 as below after Clause 3.4.3: The Applicants who have been pre-qualified at RFAQ Stage should enclose the letter of pre-qualification issued by the MORTH and need not furnish the information sought in Clause 3.4.1, 3.4.2 and 3.4.3 above.
7	In Procedure under E-Tendering, Instructions to Applicant Sub-para (d) detailed below shall be added in Para 2- (ii) (A) (d) Letter of Pre-qualification issued by the Authority in respect of the Applicants who have been Pre-qualified by the MoRTH at RFAQ stage.
